President's Letter

The light is shining brighter at the end of this long COVID tunnel as Canada's vaccination rate steadily increases, the Ontario lockdown restrictions ease, and some recent indication that, hopefully, we may finally see relaxation at the Canada-US border!! It has felt like 'forever', longing for the 'good old days', as we fought together, with the rest of the world, against the debilitating COVID virus and its multiple variants. And Crane Lake is SO ready for us, anxiously awaiting the return of her US cottagers and the resurgence of socialization amongst all her neighbours & friends!

Spring displayed nature's explosive capabilities once again with exceptional warm temperatures, excessive pollen count, and, of course, an abundance of mosquitoes, caterpillars, and flies! The lake water is already warm enough to be inviting to even those that are more timid spring swimmers! Of course, the downside is the significant lack of rainfall so far this spring. This has created EXTREME fire ratings and although recently downgraded to HIGH rating, if there is no additional rainfall soon we should anticipate the fire rating will quickly jump back up to EXTREME. It is on each one of us to remain cognizant and diligent of fire safety and avoid the devastation that accompanies fire. Please remember, there are NO FIREWORKS allowed in both HIGH and EXTREME fire ratings. The lack

of rainfall has also caused low water levels creating havoc for boaters, so be aware of submerged rocks and rock shelves during your boating travels! It's no surprise - Nature remains in control.

In our previous CLA E-blasts we alerted you to the 'fishing nets' project managed by MNRF (Ministry of Natural Resources and Forestry) on Crane Lake this summer. The Ministry has agreed they will provide CLA with a report of their findings once the projects are all complete. But I'm very excited to share with you now the recent update we received from the Project Manager at MNRF just a few days ago!

"The initial portion of the project has been a tremendous success. We have tagged/marked over 1800 fish, the biggest group being smallmouth bass making up a very large portion of the catch. Other notable marking numbers include 15 tagged muskie. Other species captured and tagged/marked include largemouth bass, walleye, northern pike, rock bass, pumpkinseed (sunfish), brown bullhead, white sucker, and yellow perch.

At the height of the project, we had as many as 13 nets fishing each night.

At this time all of the nets have been removed from the lake. No loons, ducks or other aquatic wildlife were harmed in the nets.

We currently plan on returning to Crane Lake for three smaller projects over the course of the summer. During these periods our goal will be to re-capture a portion of the tagged fish using our provincial standard Broadscale Monitoring fisheries gear.

June 21-25 July 26-30 August 23-27

It remains vitally important through the summer that if anyone catches a tagged fish and keeps it that they call the number on the tag (705-646-5543) and report its capture. We need to know as accurately as possible if a fish has been removed from the ecosystem."

This is fabulous feedback and speaks to the remarkable health of Crane Lake for our fish. I also think it makes for a difficult story when one returns from a fishing adventure with the sad story of 'no catch'! (LOL). You will have already received a recent E-Blast from the CLA with the details for the upcoming CLA AGM. *Please mark your calendars now to join us on July 14th at 7:30PM.* The Board is really excited to be with you (virtually) at our Summer 2021 virtual AGM! This is our opportunity as a community to 'come together' and learn about the exciting summer activities your CLA Board is planning for some 'fun in the sun' - and updates from the various board members on important and pertinent matters regarding our Crane Lake neighbourhood.

We are especially delighted to welcome Frank and Vivian as the new Owners of the marina! Let's all give a warm welcome to our new neighbours as they settle into their new and exciting venture on Crane Lake! And finally, maybe, just maybe, if we all wish upon the same star, no matter where we are, perhaps our wish will come true and we will all be together again soon on Crane Lake - free to socialize and enjoy our dock / deck gatherings with family and friends once again — just like those 'good old days'!

Here it is June 3 2021 and real summer weather is finally here. Most everyone I know has had at least their first vaccine and if all goes well we should all have our second by the end of July. Better late than never! Personally, I can't wait till the hair salons are back in operation so I can get my usual super short summer haircut.

Fire Ratina

As you all know, our fire rating went High a week or so ago. As of today it has been upgraded to Extreme which means a TOTAL FIRE BAN.

I share with most the disappointment of not being able to burn some brush or have a campfire in the evening. Please make it a habit to check the current fire rating on the TOA website before planning any burning. The good news is this dry spell has ended the black fly season and is slowing down the mosquitoes.

Blue Crane Marina

Crane Lake Marina has a new name — Blue Crane Marina. I'm not sure why the name was changed but I suspect the old name was not available. Please be patient as the new owners get all the necessary T's crossed and I's dotted. I'm sure it will be business as usual shortly. Please join me in welcoming the new owners Frank and Vivian Maestre to Crane Lake. Also please join me in doing whatever we can to help them become successful in their new business venture.

Clear Lake Subdivision

Unfortunately, it looks like all systems are go for the subdivision on the Seguin portion of Clear Lake. For some background, this subdivision was proposed back in 1998 when that neck of the woods was under control by Foley Township which has since become part of Seguin. At the time, the proposal was denied and fell to the OMB for resolution. The TOA at that time became involved but unfortunately the proposal was approved by the OMB with some revisions. On Clear Lake, the number of lots was reduced from 28 to 20. Still far too many for that lake.

Over the years, the subdivision plan sat dormant until a couple of years ago when they started to put in the roads to service the lots. When that happened, the MNRF was called in to check for Rattlesnake habitat destruction. As a result, the developer was charged and everything came to a halt. The charge has never been

resolved but in the interim, the Provincial Government took the responsibility for Endangered Species out of MNRF control and gave it to the Ministry of the Environment. In MOE's infinite wisdom, they granted an OK to continue with the subdivision even though the charge by MNRF has not been resolved – go figure?

So, the Clear Lake lots have been created and all that are ready have been sold. Our main fear on Crane is that the little creek that connects Clear to Crane becomes well used and perhaps altered to handle boats other than a canoe or kayak. The TOA has sent a letter of concern regarding this to the MNRF and Seguin. It will be up to us to keep an eye on that little creek and report any alterations going forward.

Well, in lieu of our regatta, CLA has decided to host a couple of fun 'physically distanced' activities around the August long-weekend this year.

The first will be the Crane Lake Online Fire Safety Quiz that you can complete as a family and submit for the chance to win PRIZES; no ribbons, but useful things like Fire Extinguishers – because you can't have too many. **STAY TUNED FOR DETAILS IN JULY.**

The second will be the Crane Lake Fire Pump Poker Run, that you can also participate in with your cottage family! *This event will be held on Saturday July 31st.*SAVE THE DATE.



The Fire Danger Ratings in the Township of the Archipelago are developed based on the past weather conditions (dryness of the forest), the current response capability of the MNRF Fire Fighting teams (what other fires are they currently fighting and where are the crews located) and in consult with neighbouring townships. Properties on Crane Lake are part of the Township of the Archipelago and are subject to these Fire Danger Ratings. These ratings are posted prominently on the TOA website at www. thearchipelago.on.ca and on roads throughout the township and must be strictly followed. You will find signs on both Blackstone Crane Lake Road and Healey Lake Road, which provide access to Crane Lake properties. These signs are updated as the fire danger rating changes, but you can find out the current rating at any time by quickly checking the website at the link above from your computer or cell phone. A picture of one of these signs is above.

Fire Danger Ratings are not set arbitrarily and are meant for the safety and protection of all residents, cottagers and their guests. Starting an outdoor fire or setting off fireworks contrary to the By-Laws is not only subject to heavy fines, but can also endanger lives and risk major damage to the forest and our buildings.

The Fire Danger Rating has 4 levels / colours and each one has its own allowances and restrictions. Here's what the levels and colours mean:

- Blue (Low) and Green (Moderate) Campfires and Fireworks are permitted, but only at the times / dates allowed in the applicable by-laws. Specifically,
 - · Campfires can only be started after 6 pm and

- must be extinguished by 2 am the following day. For more details, including allowed sizes of fires, safety precautions and responsibilities, see By-Law No. 2017-21 on the TOA website.
- Fireworks can only be set off on 3 specific dates during the year (May 24th, July 1st and July 4th), and the days immediately preceding or following these dates. Fireworks are prohibited at all other times of the year. For more details on types of Fireworks allowed, safety precautions and responsibilities, see By-Law No. 2017-20 on the TOA website.
- Yellow (High) The Fire Danger is SERIOUS and Campfires and Fireworks are prohibited, except as follows:
- Persons camping outdoors may light a fire for the purposes of cooking or personal warmth. This provision is not intended for use by cottagers that have access to contained cooking appliances or means to escape the cold. For more details refer to the By-Law No. 2017-21 on the TOA website.
- Red (Extreme) The Fire Danger is EXTREMELY HIGH / Total Fire Ban Declared – Fireworks and Open Burning of any kind is prohibited. No exceptions.

Because of a dryer than usual winter and an extremely dry spring, the Township of the Archipelago went to a Fire Danger Rating of "HIGH" just before the May 24th holiday weekend this spring, then proceeding into the "EXTREME" level, which unfortunately prohibits all outdoor fires and fireworks. While there has been some welcome rainfall, at the time of this writing we remain in "HIGH" ratings, and with a high heat summer in the forecast, we are likely

to stay in this range of ratings for the foreseeable future.

If you see anyone enjoying a campfire or setting off fireworks when not allowed, a friendly reminder to them might be in order, as sometimes cottage guests or renters might not be aware of the By-Laws or the current Fire Danger Rating. You can also report the incident to By-Law enforcement at 705-746-4243, ext. 324 (office), 705-774-3630 (mobile) or fire@vianet.ca, if you know the municipal address or can describe the exact location of the offending property. Depending on the availability of the enforcement officers, response could be immediate.

Protect Our Loons

Loons are nesting on Crane Lake once more and we all have a part to play in ensuring a safe environment for the new families. Loons nests are built very close to the water, making them susceptible to damage from boat wake. Minimizing boat wake when close to shore is always an important consideration, but it is even more vital during the nesting season to protect these young loons.

Please minimize your wake close to shore.

Loons make their nests with a mix of mud, grass, moss, pine needles and clubs of vegetation. These nests are typically built in small nooks in lake inlets close to the water, offering privacy and protection from predators. Occasionally, loons will build their nests on open water to offer even more protection from predators, putting them out of reach of foxes, raccoons, coyotes, and similar threats.

Loons gestate for four weeks and typically lay one to two eggs, with only one nesting per year. The male and female loons will coparent the chicks for around three months, then leave the now-young adult loons to find their own way. The average common loon can live up to 30 years!

Help keep Crane Lake a loon-friendly place!

It would be really great if we could get some assistance with the races. I have been the sole commodore for several consecutive years now, and could use some assistance. As you may know, we are now running two races – the usual Championship race, and a Junior Championship race for our up-and-coming sailors (those under 18). In this free webinar, we're joined by Danielle Ward from Adams Brothers Construction as she shares information on grey water pits, composting toilets, septic inspections, and more!
