WHY?

Problems can arise with septic systems that have serious impacts, including:

Overload/leaking of sewage

A septic system is designed to treat a set volume of waste water. Every time water goes down the drain into your septic tank, the same amount of liquid leaves the tank and enters the leaching bed. If too much waste water enters the tank, from extra guests, heavy water use - too much waste is forced out, too soon. Untreated waste water escapes, including solids that can clog up pipes and/or enter the leaching bed, as well.

Wiped out waste digesters

Sewage is broken down by millions of bacteria and enzymes in your septic tank and soil within the leaching bed. That bacteria is harmed or killed by (1) cleaning products that are antibacterial, non-biodegradable, chlorine-based and/or full of toxic materials; and (2) hazardous products like varnish, paint, pesticides, and gasoline.

<u>Water quality affected, algal blooms erupt, and</u> nuisance plants choke the lake

Septic systems were designed with public health in mind. They are designed to remove contaminants such as organic solids, bacteria, and viruses, but not to prevent the release of nutrients. Nitrogen and phosphorus released from septic systems can negatively impact water

quality and cause algal blooms and increased growth of aquatic plants. Excess nitrogen can also pollute drinking water, endangering people.

Build up of solids

There's a lot that can't be digested by your septic system. Fats, grease, and oils don't break down, and can form a scum layer at the top of your septic tank. Paper products, coffee grounds, hair, tampons, and other common sewage items inhibit the work of bacteria and quickly fill tanks. Combined, they can clog the system significantly hampering your septic's effectiveness.

Poisoning yourself

Hazardous products (paint, varnish, pesticides, gasoline, antifreeze) dumped down your drain, come out of the septic system just like they went in, but now they're in the ground and water with the potential to poison wells and lakes.

Contaminated drinking water and swimming areas

If your sewage is leaking, not getting cleaned, or building up, the end result could be contaminated water entering wells, ground water, lakes, streams, etc. Your health and the environment's health are at risk.

What goes in must come out

To allow waste water the time it needs to be treated in the tank, conserve water. Ensure the size of your system can handle the quantity of waste water you create. Many older septic systems may be grossly undersized.

Don't poison your poop processor

The importance of using biodegradable, non-toxic shampoos, detergents, soaps, and cleaners can't be stressed enough. Many products in your cottage are loaded weapons. Make septic-friendly products the popular choice!

Nutrients not needed

Keep the input of phosphorus to a minimum. Use lowphosphate or phosphate-free cleaners.

Have an inspector visit every 3 to 5 years

Regular maintenance is one of the most important steps. Get an inspection and your tank pumped every three to five years. Replacing or repairing a septic system (and its impacts) is expensive; maintenance keeps thousands of dollars in your pocket and emergencies at bay.

It's not a garbage can

Don't put garbage (i.e. non-biodegradable items) down your drain. That includes grease, fats, oil, and paper products.

Location, location, location

Soils play a big role in how water travels from the leaching bed, what contaminants get absorbed/broken down, and how far they travel. Your septic system must be designed for the type of soil around your cottage. Make sure your system meets the rules (Ontario Building Code) that control how far a septic tank and leaching bed can be built away from buildings, wells, and waterbodies.

Plants not trees

Plant with caution in the nutrient-rich area above the leaching bed. Do not plant trees or shrubs within three metres of the tank or bed. Roots will seek out and crack your pipes. Shallow-rooted ground covers are ideal.

Fire Committee Report Bruce Sanderson FIRE

Happy Summer of 2016 to everyone! Although not quite summer as I write this, the weather certainly feels like it, and the expert forecast is for a "warmer than average" one. Although that will be great for days on the dock, water activities and evenings on the deck, it won't be great for campfires, as there will likely be more frequent "high" and "extreme" fire ratings, both of which prohibit open fires for cottagers. This is unfortunate, but also necessary to prevent accidental fires from starting and to preserve the paradise that surrounds us on Crane Lake.

Just to give you a quick update on Fire Safety Committee Activities, here are a few initiatives currently in the works:

- Last year's AGM saw approval for the purchase of 2 more AED's (Automated External Defibrillators). As you may know, we currently have one, located on the fire boat at the marina. The two new ones will be located at the north and south ends of the lake in the pump boxes. These 3 locations will give all cottages on Crane Lake the ability to pick up a device in about the same time period in the event of a heart-related medical emergency.
- At this summer's AGM, Don Hood is scheduled to speak. As the Fire Chief for Seguin Township, Don is
 responsible for upholding the contract between the TOA and Seguin for the provision of professional fire support if
 we have to call 911 for a structure fire on Crane Lake. Don will be able to answer any of your questions about this
 contracted support.
- The fire boat will be getting an electrical re-wire in the next month or so, as some of the connections and wiring are showing their age. As the labour is being supplied by Fire Safety Committee personnel, the cost of this job will be relatively small.

We look forward to seeing everyone at the Crane Lake Regatta again this year. Start putting together your 3-person teams for the Fire Pump Relay. Not only is this event easy and a lot of fun, it helps everyone be more familiar with our portable fire pumps and how to operate them. The only challenge is perfecting your style to try and beat the fastest time on record (sub 30 seconds for those who are practicing with their local pump)! As always, Fire Safety Committee personnel will be on hand before the relay starts for coaching tips and to answer your questions. My desire would be for everyone on the lake to know how to start our portable pumps.

That's it for now. Best wishes to everyone for a great summer!

Dock & Boathouse Construction

Township of the Archipelago

If you are planning to construct a dock or boathouse in 2016 there may be delays in issuing building permits and advanced planning may provide a timely transition.

The Ministry of Natural Resources and Forestry (MNRF) has recently changed its policies regarding the requirement for authorizations under the Public Lands Act, for docks and single storey boathouses that occupy more than 15 square metres of (shadow) area over the Crown lake bed. This includes new docks, expansions of existing docks, seasonal docks and single storey boathouses, including replacement structures. Authorizations will be in the form of a Land Use Permit. In cases where construction includes works conducted on privately owned shore lands, a Work Permit will also be required from the MNRF.

Applications should be made to the Parry Sound District office via normal channels using the Ministry's standard work permit application package. If you have questions

DOCK AND BOATHOUSE BUILDING PERMITS

A building permit is required for docks and single storey boathouses according to the Ontario Building Code Act, 1992 (OBC). The Public Lands Act is applicable law under Division A, 1.4.1.3. of the OBC and therefore MNRF authorization is required before a building permit can be issued to a resident, contractor or agent.

Compliance to the Township of The Archipelago's Comprehensive Zoning By-Law A2000-07, as amended, is also required prior to the issuance of a building permit and can be viewed on the municipal website at www.thearchipelago.on.ca. It is advisable to confirm compliance with the Comprehensive Zoning By-Law before seeking MNRF authorization to provide a more seamless building permit process.



Water Safety - Maximum Speed

In the summer of 2015, we shared "Watching Your Wake", an article published by the Pike Lake Community Association and shared with members of the Federation of Ontario Cottagers' Associations. Watching your wake is an important part of responsible boating, as the impact of boat wake can be felt all across the lake, from shoreline erosion and damage to docks to creating unsafe conditions for smaller, unpowered watercraft and swimmers.

Maximum Speed Limits

Speed is another important consideration in the safe and responsible operation of watercraft. In Ontario, our waterways are subject to a maximum speed limit that applies to all lakes and rivers in the province. A speed limit of 10km/h applies within 30m (just under 100 feet) of any shoreline. This limit is a part of the Canada Shipping Act and is in effect whether signs are posted or not. To ensure that all users of the lake are aware of this provincial speed limit and to encourage all boaters to respect the existing law, the Crane Lake Association is arranging for the official Transport Canada sign to be posted at the Government Docks. A copy of the sign follows on the next page for your review. While minding your speed in areas close to shoreline, be sure to also mind your wake! 
