- A vendor take back mortgage is not available;
- If purchased, the Facility will not be a part of the residential condominium plan;
- Purchase of the Facility will not grant use of the residential condominium amenities, including the Beach which the Crane Lake Association has used at no cost for its' annual Regatta.
- The letter is an initial offer only, with specific terms of the purchase to be reviewed if interest is indicated.

Your input is critical. In advance of the AGM, please share your thoughts with the Board by connecting to us by email at cranelakeassociation@gmail.com, or visiting our post on the website, www.cranelakeassociation.ca which has a form you can easily complete. The CLA will use this input to guide the discussion at the AGM where the formal vote will be made.

# **Automated External Defibrillators (AEDs)**

This is an update on our new automated external defibrillators (AEDs). On the recent Victoria Day long weekend, our 5 new Philips Heartstart Onsite AEDs were deployed in our 5 Fire Pump boxes. The Crane Lake Association now has a total of 6 AEDs (all the same model) located around Crane Lake, including the one on our Fire Boat.

The AEDs located in the Fire Pump boxes are in bright orange waterproof carry cases. The AED on the Fire Boat is in the bin with the First Aid supplies in a red case. Also included in the bin on the Fire Boat is a knapsack with first aid items including bandages and a neck brace, an oxygen tank and masks, a burn kit, and the straps and head immobilizer pads for the back board.

As I mentioned in the last newsletter, these Defibrillators are available for anyone on the lake to retrieve in the event of a heart emergency and use to potentially save a life. We now have an AED strategically close to everyone on Crane Lake.

The Philips Heartstart OnSite model is one of the best designed and easiest to use in the world. From the moment you press the start button, it provides clear, audible instructions and adjusts to the pace you are proceeding. Most importantly, these AED'S will not deliver a shock unless they detect a heart rhythm consistent with a cardiac event, so they can't be used improperly.

I again encourage everyone to view the interactive video to familiarize yourself with how to operate these AED'S. Click on the link below, or access it from the CLA website. Even though these devices are designed to be used by anyone and provide clear instructions, for people who have never seen an AED before or if you don't know how they work, viewing the video will provide a comfort level in the event you find yourself in an emergency situation.

#### RE: Crane Lake House Resort

As you know, we are counsel for N.D. McLennan Limited, the owner of the Crane Lake House Resort (the "Resort"), in the Township of Archipelago. We write further to our letter of May 25, 2017.

Our client has applied for a condominium conversion for the Resort. We understand that your Association expressed an interest, some two years ago, in purchasing the banquet facility portion of the building which contained the restaurant and banquet facility (the "Facility"), of the Resort while it operated. We are not aware of any express interest or attempts to contact our client to proceed with the purchase.

We kindly ask that you circulate this request to your Association. We ask that, should the Association be interested in purchasing the Facility you let us know no later than 4:00 pm on July 17, 2017. If we do not hear from you by this time we will presume that the Association has no interest in purchasing the Facility.

Provided we receive such notice, our client is willing to consider selling the Facility for \$700,000.00. A vendor take back mortgage will not be available. Also, although the specific terms of the purchase would need to be reviewed, the Facility will not be a part of the residential condominium plan and therefore any future owner(s) of the Facility would not have use of the residential condominium amenities made available to the residential condominium unit owners, including but not restricted to the tennis courts, beach area and playground.




# Bylaw Changes in our Township

This spring, the Township of the Archipelago (TOA) updated some of their by-laws and introduced a new one. This article is not meant to be an exhaustive review of the by-laws, but I thought it would be informative to itemize a few of the changes that affect cottagers on Crane Lake. The highlights are below:

The Outdoor Burning By-Law has been updated as By-Law No. 2017-21 and repeals the previous By-Law No. 2004-36. Key points for Crane Lake cottagers are:

- Fires started outdoors must have a person in charge at all times and that person must remain in line of sight with the fire until it is totally extinguished.
- Do not start a fire without having adequate materials or devices (i.e. pails of water or a hose on hand) to extinguish the fire.
- During "Fire Season" (April 1 to October 31), open air fires, campfires or recreation fires cannot be started before 6 pm and must be extinguished not later than 2 am the following day.
- Campfires cannot be larger than 1 metre in diameter and 1 metre in height and must be at least 5 metres from any flammable materials.
- Campfires cannot be started unless the Fire Danger rating is Low or Moderate.
- Fires for cooking or warmth may be started when the Fire Danger rating is High, but campfires are not allowed. (This applies only to outdoor camping within



the TOA, as it is understood that if a cottager needs to cook or get warm when the Fire Danger rating is High, they can go inside).

- When the Fire Danger rating is Extreme (which is also known as a "Fire Ban"), absolutely no outdoor fires are allowed in the TOA.
- Municipal By-Law enforcement Officers are authorized to enforce the by-law and can charge fines from \$225 to \$425 (minimum fines for a first offense).
- In addition to any fines or penalties, person(s)
  responsible for setting fires are also liable to the
  Township for costs related to investigating complaints
  and or controlling or extinguishing the fire.

A new By-Law has been created to regulate setting off Fireworks, By-Law No. 2017-20. Key points for Crane Lake cottagers are:

- No Fireworks can be set off when the Fire Danger Rating is "High" or "Extreme" (same as for camp fires).
- Firecrackers and Sky Lanterns are banned within the TOA.
- Consumer Fireworks can only be set off on Victoria Day (the May 24<sup>th</sup> Holiday), Canada Day (July 1<sup>st</sup>) and Independence Day (July 4<sup>th</sup>) and/or the one day immediately preceding and/or following each of these days. The day before and after clause is an important change, whereas many people on Crane Lake were in contravention of the old by-law when they set off fireworks on the Sunday night of the Victoria Day weekend. This behaviour is allowed under the new by-law.
- Fireworks are only allowed between 6 pm and 11 pm on the allowed days.
- Persons under the age of 18 cannot set off fireworks unless they are under the direct supervision and control of a person 18 years of age or older.
- Suitable fire extinguishing equipment must be available at all times.
- Property damage or injury resulting from setting off fireworks is the responsibility of the person setting off the fireworks.


- Municipal Law Enforcement Officers (By-Law enforcement) are authorized to enforce the by-law and can charge fines from \$225 to \$610 (minimum fines for a first offense).
- In addition to any fines or penalties, person(s)
  responsible for setting fires are also liable to the
  Township for costs related to investigating complaints
  and or controlling or extinguishing any fire started by
  the setting off of fireworks.

In addition to updating the By-Laws, the Township has simplified the Fire Danger Rating chart by combining the "Fire Ban" level with the "Extreme" level. The new chart is shown below. There is also an icon / link to the chart on the home page of the TOA and the Fire Danger rating is clearly shown on the home page.

#### **Boat Speed**

In the summer of 2015, we shared "Watching Your Wake", an article published by the Pike Lake Community Association and shared with members of the Federation of Ontario Cottagers' Associations. Watching your wake is an important part of responsible boating, as the impact of boat wake can be felt all across the lake, from shoreline erosion and damage to docks to creating unsafe conditions for smaller, unpowered watercraft and swimmers. #### Maximum Speed Limits

Speed is another important consideration in the safe and responsible operation of watercraft. In Ontario, our waterways are subject to a maximum speed limit that applies to all lakes and rivers in the province. A speed limit of 10km/h applies within 30m (just under 100 feet) of any shoreline. This limit is a part of the Canada Shipping Act and is in effect whether signs are posted or not. To ensure that all users of the lake are aware of this provincial speed limit and to encourage all boaters to respect the existing law, the Crane Lake Association has arranged for the official Transport Canada sign to be posted at the Government Docks. A copy of the sign follows on the next page for your review. While minding your speed in areas close to shoreline,

#### **Boat Wake**

There was a time when a "BIG BOAT" on Crane Lake was a 16 foot "runabout", with a 60-70 HP, outboard motor! Today, newer boats to the lake are more in the range of 18 to 25 feet and have I/O or inboard engines. Many, such as wakeboard boats, are designed with the express purpose of maximizing wake produced. While this has resulted in amazing wakes/waves for wakeboard/waterskiing enthusiasts, if not used responsibly, these watercraft and other larger boats can produce undesirable consequences for our shorelines such as excessive erosion and disturbance of wildlife habitat. Docks, swimmers, smaller non-motorized watercraft and other personal property can also be put at risk from excessive wakes.

#### What Can You Do To Help?

When travelling close to shore (less than 30 metres or approx. 100 ft), or in channels, such as Little Narrows or the Windy Narrows, the answer is not to just to reduce to the 10 km speed limit in these areas. Sometimes, just dropping speed can keep the bow up, potentially producing the largest wakes. The answer is to *Slow Right Down, Bow Down, Wake Down, Idle Speed.* 

Your fellow cottagers, swimmers and boaters will thank you for your boating courtesy!

Lastly, consider using the "BOATERS CODE" from Safe & Quiet Lakes as your guideline to safe and responsible boating practices. The Code is printed in this newsletter, following the Transport Canada sign. Additional resources and information can be found at safequiet.ca.

# BOATER'S COLDE

### Respectful boating guidelines from Safe Quiet Lakes

- 1. I will never operate my boat beyond the level of my skills.
- I will be aware of and obey all laws and regulations governing operation of my boat.
- 3. I will operate my boat with caution and courtesy to others at all times.
- I will minimize my wake impact on shorelines, docks, structures and people.
- I will always steer well clear of other boats, swimmers and wildlife.
- 6. I will set a speed and heading that is safe and comfortable for my passengers and others on the water.
- I will provide safety instructions and offer appropriate life jackets or PFDs to everyone who travels in my boat.
- 8. I will carry all equipment necessary to operate my boat safely and within the law.
- I will not consume alcohol in my boat or allow my boat to be operated by anyone who is impaired.
- 10. I understand that boating is a shared experience and I will not create excessive noise or operate my boat in a manner that disrupts the peaceful enjoyment of the lake by others.

As of May 31, 2017, our combined bank/savings balance was \$35,451.09. The fund activity is summarized below:

Our membership target for each year is 140 paid members, which would mean \$7,000 each of Operating and Capital fund income. We did not hit that target, as we received only 129 members paid for 2014; however we also had 1 membership paid in advance for 2017, and 10 memberships that caught up on their prior year(s) membership dues.

Based on our forecasted income and expenses, including reaching our target of 140 paid members for 2017, 2016, and 2015; we expect to end 2017 with \$38,358 combined bank/savings balance. The forecasted fund activity from now to the end of the year:





As I boat around our lake I see a few cottages which may not understand how vital it is on maintaining trees and vegetation on the shore line. On another note growing grass near the waters edge will only increase the geese population which will lead to poor water quality as they feed on grass and grow in numbers using our lake as a waste disposal. I have been on the lake for over 40 years and never seen geese breeding on Crane Lake until the last ten years. It's all up to us all to keep the balance on this sensitive environment.
